FEE SCHEDULE

Based on your income and assets you do not qualify for a free Public Defender. If you wish to be represented by a Public Defender, you must sign a contract agreeing to pay the department for your representation at the following rates. The contract amount will be for the highest charge listed on the criminal complaint, grand jury indictment or petition **at the time of application**. Since you do not qualify, you are encouraged to hire a private attorney as soon as possible. If you are unable to hire a private attorney, you may sign a contract with the LOPD according to the fee schedule below.
