Chief's message

What a tough summer! As of the release of this newsletter, it's been 8 weeks since the first wave of our cyber incident hit us. As we stand, except for CCLS, our emails are back online and back to working with court partners. Our third-party cyber specialists are still working on our servers and all the files stored in them. Who did this to us? How did they do it? Why? All that is under investigation as of this newsletter, and the cyber security specialists will certainly guide how and how much of that information can eventually be released.

What we do know is that we are resilient and even when things get really difficult, we keep our clients as our focus — which brings me to our Ruidoso office.

Just 10 days before our cyber incident, their village was burning between two different wildfires and then was hit -- and continued to be hit -- with destructive flooding. Each person in that office had friends or family whose homes were destroyed. Several of our employees had to evacuate their homes. Cornerstone businesses and landscapes of their community were lost. And still, they focused on our clients.

I can't tell you how moved I was when I heard that even as the town was on the brink of burning and evacuations were being ordered, our paralegal Katina Slaughter and social worker Ashely Ventura were calling our clients, including competency clients with whom they'd built trust, to encourage them to evacuate. They were talking to our clients in the jail and updating them. They were working with the court and transferring phone lines and calling clients with scheduled hearings. As the unpredictable floods came and went, our staff opened then closed then opened our office again.

And in the middle of all of this, they endured the cyber incident. Without internet and some without home offices, the team gathered at Attorney Rachael Sutherland's house, which still had internet service, to continue to help our clients. Fortunately, the office is now open and up and running, and it looks like they have come out the other side of the most difficult times.

Our thanks to all of you to those who donated to them through the GoFundMe, or directly. And thank you, my Ruidoso colleagues. Your last three months have been a defining challenge, and you all have revealed your heart and your character. Your story and many other things in this newsletter are a reminder that there is still so much good around us.

LOPD Emergency Alert System to launch soon




Whether it's a wildfire alert in Ruidoso, an unexpected office closure or a weather delay anywhere in the state, a new LOPD Emergency Alert System called Everbridge will be coming online soon.

Everbridge allows department leaders to send emergency alerts or updates via texts, emails, calls, social media, and the Everbridge app. The system can target specific areas, like individual offices or even specific floors. More information will be coming soon about this tool, followed by trainings.
